



NTUC Membership Referral Programme

TERMS AND CONDITIONS

1. The NTUC Membership Referral Programme (the "Promotion") is open to NTUC Members who are not in arrears of their membership fees ("Members"). This Promotion is not open to nEbO members.

Promotion Period

2. The qualifying period for this Promotion is from 1 June 2018 to 31 January 2020, both days inclusive ("Qualifying Period").
3. Eligible NTUC Members who introduce one or more contacts via NTUC's website in accordance with these terms and conditions are eligible to participate in the Promotion within the following period:

4. Members will be entitled to receive one \$10 NTUC FairPrice voucher ("Voucher") for each Successful Referral.
5. The redemption letter for the Voucher(s) will be mailed to the Member's address as recorded in the NTUC's database, four (4) weeks after campaign end date. For instance, if the qualifying period is from 01 February 2019 to 31 March 2019, the redemption letter will be mailed to the Member's address by 30 April 2019. Please note that it is the Member's responsibility to update NTUC if there has been a change in his/her mailing address.
6. A "Successful Referral" is made when an NTUC Member introduces a Contact who completes and submits his/her NTUC membership online application at NTUC's website at www.ntuc.com.sg/membership and indicates the referral code on the online application form within each of the promotion period. In order for the Member to qualify for the NTUC FairPrice voucher(s), the Member's Contact must become a paying NTUC member within 1 month from the closing date of the promotion. For instance, if the qualifying period is from 01 February 2019 to 31 March 2019, a Contact must become a paying NTUC member by 30 April 2019. In addition, the Contact must not have terminated his/her NTUC membership within 3 months prior to the Qualifying Period and must not be in arrears of his/her membership fees.
7. If more than one member introduces the same contact, only the member whose referral number is indicated in the approved application will be awarded the voucher.
8. There is no limit to the number of contacts that a Member can introduce.
9. NTUC's decision on all matters relating to the Promotion, including the time of receipt of the NTUC Membership Referral Programme Application Form, is final.
10. NTUC reserves the right to vary, delete or add to any of these terms and conditions from time to time at its discretion and without prior notice. These terms and conditions shall prevail over the contents of any brochure or other promotional material advertising the Promotion.
